#### **Pending Grant Applications**

Priority Charter Schools shall provide public notice of federal grant applications through an information item either at a Board meeting, a public hearing and/or by publishing information on the school's website. The School shall make available opportunities for public input as required by law or the granting agency.

#### 2024-2026 Effective Schools Framework - Focused Support Grant

The ESF Focused Support Grant provides resources and support to school districts and charter schools to ensure that campuses identified for improvement reach full implementation of the Foundational Essential Actions in the ESF to significantly and sustainably improve student outcomes. These funds must only be used to support schools and school-level improvement efforts to directly benefit the awarded Comprehensive, Targeted or Additional Targeted schools. The school may reserve up to 30% of the total awarded funds at the district level to assist students who will be entering and/or have existed the federal identified campuses to address the gaps that were created on the Comprehensive, Targeted or Additional Targeted campuses. The grant will fund applicants during a two-year grant period ending on September 30, 2026. Districts must satisfactorily complete the required elements of the ESF-Focused Support Grant program Guidelines and provide data and information to the Texas Education Agency.

We have grants for the following campuses: Priority Charter Schools (PCS) – Cove and PCS – Temple.

### II. Adjourn Meeting

Pursuant to the Texas Open Meetings Act, Chapter 551, Tex. Gov. Code, one or more of the above items may be considered in executive session, which is closed to the public under Sections 551.071, 551.072, 551.073, 551.074, 551.076, 551.087, 413.183(f), and 418.106 (d) and €, The Board will not take action while in executive session, but only upon reconvening in open session. In accordance with Texas Attorney General Opinion, the purpose of the Open Meetings Act is to ensure public access to meetings of governmental bodies so that they have the opportunity to be informed about the transactions of public business. It does not provide a public forum for citizens to express opinions. However, if the governmental body decides to allow citizens input, it must not unfairly discriminate, but may establish reasonable restraints on the number, length, and frequency of presentations. Any citizen wishing to address the Board regarding a grievance must follow the adopted grievance policy before approaching the Board. Any citizen wishing to address the Board for any matter not regarding a grievance must request inclusion on the agenda at least 2 working days prior to the posting of the agenda. All requests must be made in writing, must be signed, and dated. Requests may be sent to the notice of the superintendent at the administration office. Agendas will be posted at least 72 hours in advance of meetings.
